We also broadened our relationships with the cities we serve in 2009. In addition to our long-standing relationships with the cities of Kent and Covington, we developed a new relationship with the City of Federal Way. We are proud of our work on behalf of the children, youth, and families who, not only call Kent and Covington "home," but now Federal Way as well.

In our definition of "community", we include the various entities of support and service. our mission

Kent Youth and Family Services provides professional counseling, education and support services to children, youth and their families in our community, developing innovative programs that meet the evolving challenges of our diverse community in culturally sensitive ways.

hottshotts

"HottShotts" espresso stand continued to steam up business in 2009! Operated by KYFS, and located at the Norm Maleng Regional Justice Center in Kent, HottShotts offers job-skill training and promotes good work habits to adjudicated and at-risk youth. Under the supervision of on-site adults, these youth served a delicious array of hot and cold beverages, sandwiches, and sundries to the public. In addition to communicating with the general public, these youth also have the opportunity to interact with a community of professionals, which includes judges, other elected officials, jurors, police, members of the print and broadcast media, and King County staff, all while providing a quality product and good customer service! Since acquiring the operation from King County Work Training Program in 2001, King County Facilities Management has partnered with KYFS in the operation of HottShotts. As in preceding years, it was a successful partnership throughout 2009.

- Hundreds of customers were served each day.
- Three youth completed six months of training as full-service baristas.
- · Participants developed self-confidence to help successfully gain independent employment.
- The experience encouraged participants to return to school, complete their education, and to pursue higher education.
- HottShotts created a positive work environment.
- We worked to enhanced customer service and expand product lines.
- We maintained our partnership with King County Facilities Management.
- We continued to better our community, one youth at a time.

watson manor

The Watson Manor Transitional Living Program provides up to two years of transitional housing and support services to single, homeless, and extremely low-income* teenage (and young-adult) mothers and their children. Each young mother is parenting one to two children or is at least six months pregnant. During 2009, Watson Manor responded to the evolving challenges of the region's homeless community by broadening the target age range from 16–20 to 16–25. Services were tailored to each resident's specific needs and included case management, parent education, life skills training, counseling, substance abuse services, and referral to childcare, educational, and vocational programs. Watson Manor prepares homeless young mothers to live independently in their communities of choice, increasing their self-sufficiency and equipping them with the skills necessary to obtain and retain permanent housing.

Housed in a 10-unit apartment building, owned and operated by KYFS, partnership with the local community, and beyond, provided the the Watson Manor program fosters a feeling of community among its necessary capital to undertake a renovation that provided a new culturally diverse residents. The facility is occupied by program participants metal roof, gutters and downspouts, improved insulation, ventilation, and residential staff members, who provide on-site supervision and and drainage, and a re-surfaced parking lot. assistance. Each young mother experiences the independence of her own one or two-bedroom apartment, while benefiting from a supportive * Extremely low income is defined as at or below 30% of Area Median Income (AMI). community. Watson Manor's location in a residential neighborhood lends itself to integration into the local community.

substance abuse program

KYFS Substance Abuse Treatment services include adolescent prevention, intervention, and treatment. We offer a spectrum of treatment options for youth with substance issues. Young people, and their families, receive professional guidance and learn successful strategies, to abstain from using harmful substances. Families and communities are strengthened through appropriate education and counseling. In 2009, the KYFS Substance Abuse Treatment Program delivered 6,693 hours of direct client service, with 83.1% of our clients completing treatment.

Our department serves many communities in South King County; including Kent, Black Diamond, Federal Way, Renton, Auburn, Covington, Maple Valley, Tukwila, SeaTac, Burien, and Des Moines. Many of these communities are showing an increase in risk factors associated with substance use. These risk factors include an increase in drug availability, a rise in transitional situations for both families and individuals, and an increase in economic stress and poverty related issues.

Young people in our program are usually referred to us through the school system or the judicial system. Those who are involved with the judicial system are referred by Youth Accountability Boards. These Boards are comprised of community volunteers who help link youth with services that aim to decrease risk factors related to substance abuse and the judicial system.

The KYFS Substance Abuse Treatment Department has several programs for youth, including "Back on Track". This program is for youth who may be at risk for future substance abuse or other problematic behavior. The program focuses on life skills such as positive communication, decision-making, anger management, stress management, and resistance to peer pressure. For young people who are addicted or abusing substances, the focus is on increasing self-esteem, sense of purpose, positive view of future, resistance to peer pressure, personal responsibility, and decision making skills.

Watson Manor routinely draws on the strength of the surrounding community, collaborating with other KYFS programs, as well as the wider community of human service providers. Area businesses, organizations, local jurisdictions, church groups, service clubs, and individual community members donate goods and services to Watson Manor residents and play an important role in maintaining the facility and grounds.

During 2009, Watson Manor was awarded federal stimulus funds administered by the City of Kent. We are so appreciative that this

youth & family counseling program

ONGOING SERVICES

The KYFS counseling program continues to provide services that communities throughout South King County have come to rely on. In 2009, our program offered the following:

- Over 5,000 hours of direct counseling service for youth and their families.
- Therapeutic services, provided in the client's native language, via bilingual therapists or translators.
- Counseling services to Head Start and ECEAP children and their families.
- Positive and enriching environments for Master's Level interns from local universities.
- Group anger-management counseling for boys, girls, and teens
- Onsite therapists in 16 Kent District schools, present at least one day per week.
- Collaboration with the Society for Council Representing Accused Persons (SCRAP) for Project ROYAL (Raising Our Youth As Leaders). Project ROYAL is an intervention for African American youth involved in the Juvenile Justice System. It is designed to reduce recidivism through intervention, empowerment, and case management services.
- Financial literacy programming, offered in partnership with the City of Kent.
- Mental health counseling and family planning services, at the Kent Phoenix Academy Health Center, through our partnership with Public Health Seattle King County.

NEW SERVICES

In 2009, Kent Youth and Family Services Counseling offered several new programs, all strategically designed to meet prevention and intervention needs of individuals and families. These new services included the following:

- Co-Occurring Disorders Treatment Designed to meet the needs of youth struggling with mental health and substance abuse/dependence issues.
- Infant Mental Health Counseling Designed to help prevent problems later in life, while enhancing the parent child relationship. This service is provided in collaboration with Navos Mental Health, Auburn Youth Resources, and Renton Area Youth Services.
- Coming Up Supportive Housing Program This program serves homeless youth in South King County, in collaboration with Valley Cities Counseling and Consultation and Auburn Youth Resources. It is the first program of its kind in King County.
- Race, Culture, and Gender Committee Provides counselors with ongoing education and activities to increase cultural awareness, so that we can offer informed and sensitive services.

In spite of difficult financial times, the KYFS counseling staff has been able to enhance existing partnerships and develop new ones. We received program funds from the cities of Kent and Covington and King County, United Way, and private contributions. This support allows us to expand services, to meet the needs of our community. For both staff and clients, 2009 was an amazing year in which we continued to find meaning in ourselves, our relationships, our families, and our community.

We are thankful for the opportunity to witness and be a part of each, and every, client's life. We are moving forward in 2010 with optimism, enthusiasm, and hope for all people in our community.

head start & early childhood education & assistance program

Our Head Start and Early Childhood Education and Assistance Program (ECEAP) classes offered comprehensive, high-quality preschool education to 533 children in 2009. We also provided support services to their families. Through long-term partnerships, we were able to offer programming in four locations throughout the Kent School District (KSD). We have eight classrooms located in the Kent Family Center (on King County Housing Authority property), two classes offered at Panther Lake Community Church, and two classes within Kent Lutheran and Holy Spirit Churches in downtown Kent. Based on the selection criteria, we enroll families that require intensive services and are in the greatest need.

Strong community partnerships are essential in early education. The following organizations and agencies helped provide quality services for the children and families in our programs.

- Through our partnership with the Kent School District's Special Education Department, 19 children received additional support services to assist with their skill-development and preparation for Kindergarten.
- In partnership with SeaMar and Smile Partners, these children received dental screenings and fluoride applications twice a year, with referrals made to local dentists for follow-up treatment.
- Renton Technical College provided daily, on-site ESL classes at the Kent Family Center building, serving over 55 adults.

Research over the last several years has shown that all subgroups of children in our programs gained language, literacy, math, cognitive, and emotional skills. The program's rate of success is 93%, based on the indicators of "children demonstrate age-appropriate language skills, children exhibit age-appropriate behavior and social skills, and children are able to engage in structured learning and play time."

Teachers rated 95% of the children as having gained social and emotional competence for kindergarten by the end of the program year. This success is important because these skills provide an essential foundation for interpersonal relationships, learning, and school success in future years.

• Puget Sound Educational Service District provided not only the funding for the Head Start & ECEAP programs, but also technical support, data collection and evaluation, and research and trainings in best practices.

Our community of families is comprised of a diverse population. Of the 531 families served last year, we found diversity in ethnicity, education, languages, and family structure:

- 69% are persons of color.
- · 49% of the parents did not graduate from high school, while 38% had their high school diploma or GED. 15% had advanced education.
- 37% of the children came from female single-parent households.
- 96.5% are at the Federal Poverty Level or below.

outreach

In 2009, the Outreach After School program partnered with several agencies, to help enrich the lives of local youth, as well as the health of our community. We received effective results and wonderful feedback (such as the Community Partners of the Year award, from the Girl Scouts of Western Washington).

Our goals targeted the idea that it "takes a village to raise a child." Our focus was on providing tools to help community members achieve self-sufficiency and provide our youth the resources to be successful. Each day, we engaged over 420 young people with creative, educational, and recreational activities; cooking workshops, computer classes, and sports, as well as life-skills workshops and job training. We structured our activities to build on academic success, life and social skills, community involvement, drug resistance, and cultural awareness.

Outreach reflects an enduring commitment to diversity and cultural understanding. Not only is our population diverse, but 65% of our staff reside in the communities we serve. It is critical to practice culturally competent ethics and raise awareness within our communities. Every year, we are privileged to be involved in many important cultural events, including parent and community meetings, weddings, and sporting events. It's an honor to participate and contribute towards cultural awareness.

Thanks to many volunteer and provider partnerships, Outreach provides our community with vital tools and resources. We offer direction towards healthy and rewarding lifestyles by encouraging literacy, education, community work, and resistance to drugs and violence.

2009 LIGHTHOUSE PROGRAM STATISTICS

- Total membership reached an all-time high of 560 girls and boys.
- Over 200 youth received tutoring and homework help.
- Members of the community donated over 300 hours of volunteer time, to aid and assist Lighthouse staff.
- 80% of Lighthouse participants engaged in Homework Help, a drop-in program, where students work with trained staff members.
- Lighthouse youth participated in the Bridging the Gap Program. Sponsored by the Kent School District, this program provided technology to disadvantaged families in our community. Not only did our youth receive access to equipment and services, but worked as assistants to the program as well.
- Lighthouse staff members were instrumental in accessing transportation to the Cedar Heights Food Pantry for families in the Birch Creek community.
- Lighthouse members and staff participated in the Community/Family Night Resource Fair at Cedar Heights Middle School.
- 65 children attended an Alcohol Town Hall Meeting that provided information on the dangers of alcohol use among youth in the community.
- Over 60 youngsters attended Youth Relationship Skills classes held at both Lighthouse sites.

THE CITY OF KENT

In 2009, the City of Kent awarded \$211,000 to KYFS through the "Recovery and Reinvestment Act" (RRA). This federal stimulus award funded a new roof at Watson Manor. The roof replacement has been a "shovel ready" project while attempts were made to secure necessary funding. Although the City of Kent provided a portion of the funds in 2008 (through a CDBG award), replacing those funds with RRA funds allowed the project to be completed in 2009. The City of Kent's confidence in KYFS to manage the funds, and complete the project, clearly demonstrates Kent's willingness to invest in our community and support housing services.

CLEARCHANNEL OUTDOOR AND MIKE OKAZAKI, EXECUTIVE DIRECTOR, NEIGHBORHOOD HOUSE

Just as KYFS was searching for new ways to publicize our services, Mark Okazaki, Executive Director of Neighborhood House (www.nhwa.org) recommended us to ClearChannel Outdoor who offered to contribute digital billboard space to KYFS.We were able to utilize mass market "digital" advertising for the first time and with ClearChannel Outdoor's help, we went live in July 2009. 


